FINANCIAL REPORT:

Checkbook: Current balance \$37,440.10.

- 2012/2013 Programs/Calendars = \$3638.
- Fall concessions gross \$8,886.98 net \$3,628.18 (\$600 startup money given to Kellie on 8-15-12). Winter concessions gross TD \$16,407.12 net \$10,211.25. There are still bills outstanding for winter concessions and some of the income may be attributed to Cougar Wear but at this time we are unsure of the breakdown. Will get information on any deposits made by Kim L. The amounts above do not include concessions income after 2/13/13 which should be substantial based on activity over the weekend.
- Cougar wear gross \$13,526.30 with net (-\$5,487.54) starting inventory on a cost basis is \$3,996.40. Apparel for the golf tournament was \$580.
- Cougar Card deposits to date \$31,144 Continue to exceed goal.
- Memberships are now at \$700 and Sponsorships at \$4725. Brick deposits this year at \$75.
- Golf Tournament gross \$3,830 with net \$3,156 w/o any adjustment for Cougarwear given away.
- 2 NSF Checks have been reported for \$10 and \$45.
- A Jersey Mikes fundraiser was conducted last month. Deposits are not yet in the account but should be approximately \$900.

REQUESTS:

- <u>\$1200</u> requested by Swim and Dive to replace a diving board. Total cost of replacement is \$4,000 of which West Booster Club will contributed \$1200, Community Ed \$500, East PE \$300 and Mankato Area Diving Club \$800.
- **\$825** requested by Dance Company for yoga pants to be used for half-time performances. 30 pair at \$27.50/per. These are to be kept in inventory on an on-going basis.
- Other items to think about for future expenditures: Spring sport needs and Wolverton Scholarship Fund in place since 1980/81 for which funds have run out (\$1000 to give out per year @ \$500 male athlete and \$500 female athlete).
