MINUTES: Minutes of the May meeting reviewed – M/S/P –Ruth/Dawn

#### **FINANCIAL REPORT:**

**Checkbook**: Current balance \$31,593.90 – includes Kwik Trip balance of \$1,590.52 and \$15,000 committed to stadium project. We want to retain \$2500-\$3000 in account over summer.

- Memberships = \$650 and Sponsorships = \$5,455, Total \$6,105. (\$6150 total in 2013-2014).
- **2014/2015 Programs/Calendars** = \$606.40.
- Concessions: \$600 start-up given to Kellie 8-13-14. Seasonal Detail: Fall concessions Gross \$14,706.52 with Net \$6,297.80. Winter concessions Gross \$25,110.46 with net \$10,264.75 (still an issue with Walmart/Sam's Club Credit. We have received more letters from them indicating they will resolve the problem but still have \$1000 of our money). Spring Concessions Gross \$7,870.77 with net \$4,547.35. (2013-2014 Season Concession Total Gross equals \$38,952.63 resulting in net income of \$21,485.48).
- **Cougar Wear** Gross \$14,402.62 with net of \$4,384.02. (2013-2014 Gross Sales of \$16,912.18 with Net \$3,005.17).
- **Cougar Cards** \$34,345...another record. (2013-2014 Total = \$33,013). We do have about \$1700 in expenses but have never netted this out of this total before for reporting purposes.
- **Golf Tournament** –net \$3,208. 2013 = \$3,506.75 net.
- Pack the stands West home event this year.
- Snell Fundraiser \$3,036.00.
- **Kwik Trip Account** \$1,590.52. Program changed as of January 1 = used to be 10% of sales to group, now 5% to group. We will have one more set for this school year.
- **2 NSF checks** remain outstanding. 5 Collection letters went out and 3 have been paid. One was returned with no forwarding and the phone number is no longer active. Two that remain outstanding = \$170 + \$12 bank fee each.
