FINANCIAL REPORT:

Checkbook: Current spendable balance is \$57,049.36 which does not include the stadium project or Kwik Trip sub-accounts.

- Memberships/Sponsorships: \$4,928
- **2015 Programs/Calendars:** \$6,800, including \$1,300 for Spring programs and \$2,900 for Fall programs.
- **Concessions**: \$600 start-up given to Kellie on August 3, 2015. 2015 Fall: Gross \$16,411.57/Net \$9,003.53
- **Cougar Wear:** Current year gross to date is \$14,330.93 with net \$2,840.50. Beginning inventory \$2,294 and starting cash \$216. 2014-2015 Gross \$14,402.62 resulting in net income of \$4,384.02.
- **Cougar Cards:** \$40,931 so far for 2015. Highest amount ever. 2014=\$34,355 and 2013 = \$33,013.
- **Golf Tournament:** September 27, 2015 tournament = \$2,316. 2014 = \$3,208, 2013 = \$3,507
