## FINANCIAL REPORT:

Checkbook: Current balance $\$ 43,714.70$. Available balance $=\$ 38,671.90$ after subtracting Pack the Stands money.

- Memberships/Sponsorships - Deposited to date $\$ 630$ for memberships and $\$ 1400$ for sponsorships. This does not match DeDe's report, Rick to investigate if money was tied to another department.
- 2013/2014 Programs/Calendars = \$5200.
- Fall concessions - Gross $\$ 11,566.67$ with Net $\$ 5,631.36$. $\$ 600$ startup money given to Kellie on 8-1213.
- Cougar Wear - Gross $\$ 12,837.47$ with Net $\$ 853.66$. Beginning inventory on cost basis = value $\$ 7,087$. \$300 startup money given to Darcia on 9-16-13.
- Cougar Cards - \$2,529 so far. Highest amount to date.
- Golf Tournament - \$3,506.75 net.
- 2013 Pack the Stands - $\$ 5,042.80$ (included in account balance above). Once net is final it will be divided among the 4 soccer teams (MEHS Girls, MEHS Boys, MWHS Girls and MWHS Boys).
- One NSF check received thus far for $\$ 50$.

## REQUESTS:

1. $\$ 900$-Girls Basketball practice gear. Every $4-5$ years this needs to be replaced. Both programs (boys and girls) have requested this in the past. This amount covers the entire bill.
2. $\$ 2,400$ - New Pants for JR HIGH baseball and softball - This request would cover 50 pairs of pants for each (baseball and softball) at $\$ 1200 /$ sport.

fronts. There will be some upgrades to facilities as part of the recently passed referendum, but this project would not be included in those requests.

These totals don't currently match Rick's financial report. He will investigate. Both are less than they have been in the past. Cougar Wear/Cougar Den - New apparel should be available soon. Discussion was help regarding branding via use of our logos. Examples of future logo uses were presented with the recommendation that we move forward with 2-3 only and encourage all others to use these logos in their team apparel. Marketing: This committee met to discuss developing a Member Appreciation Program

- Member Appreciation Card - Card to be mailed to all current membership and sponsorship holders. Card would be mailed along with an informational piece explaining the program.
- Member Appreciation Events - Cardholders entitled to special events and benefits (example promotional evenings, promotional drawings, etc.) Events would be supported by outside organizations that would be able to supply giveaways to our members/sponsors (example - one night sponsored by Nighthawk Graphics or B Stark with the grand prize being one of their apparel items).
