### **FINANCIAL REPORT:**

**Checkbook**: Current balance \$48,088.96.

- Memberships = \$570 and Sponsorships = \$4255. (\$6150 total in 2013-2014).
- 2014/2015 Programs/Calendars = \$6000. No invoices paid yet and two more payments to collect.
- Concessions: \$600 start-up given to Kellie 8-13-14. Seasonal Detail: Fall concessions Gross \$14,706.52 with Net \$6,297.80. Winter concessions Gross \$0 with net \$0. Spring Concessions Gross \$0 with net \$0. (2013-2014 Season Concession Total Gross equals \$38,952.63 resulting in net income of \$21,485.48).
- Cougar Wear Gross \$11,312.27 with net of \$1,993.67. \$346.00 deposit 11/24/14 not included. (2013-2014 Gross Sales of \$16,912.18 with Net \$3,005.17).
- Cougar Cards \$34,085...another record. (2013-2014 Total = \$33,013). We do have about \$1700 in expenses but have never netted this out of this total before for reporting purposes.
- Golf Tournament –net \$3,208. 2013 = \$3,506.75 net.
- Pack the stands West home event this year.
- Kwik Trip Account account now empty.
- 2 NSF checks remain outstanding. 5 Collection letters went out and 3 have been paid. One was returned with no forwarding and the phone number is no longer active. Two that remain outstanding = \$170 + \$12 bank fee each.

**Program Books:** On track with spend at approximately 1/3 of annual amount (\$2600). Committee: Todd

**Cougar Wear/Cougar Den:** Will open a couple times in December. We have received a request for a donation from Cougar Boys Hockey for Zach Fox fundraiser (previous West player). Committee: Jean, Darcy, Arlin Penner, and Deb Rabenhorst.

Marketing: No report. Committee: Darcy, Jean, Dawn and John.

**Stadium Project:** Steering committee met last week. Cost will be about \$600K. Project in 3 phases: Bleachers/Press Box \$225K, Entrance to Building \$275K, Plaza Landscaping \$100K. Marketing pieces being developed to put out to large donors. Dan Nourie will be general contractor. We need to finalize our commitment to the project (example: \$10,000-\$15,000/year over 4 years). Next meeting is scheduled for December 10<sup>th</sup>.

### **OLD BUSINESS:**

- Buick of America/Snell fundraiser = East's share is \$3,036 (60% of total \$5,060). John will reach out to Kia and Ford to see if they have similar programs.
- Need to double check on the checks from BW's.
- Still need to receive Pack the Stands check from West (will be about \$1600 to the soccer teams).

### **NEW BUSINESS:**

- Pie-ology wants to partner with us for a fundraiser 20% of sales back to East.
- Jersey Mike's is discussing running the \$2 sub fundraiser again.
- Renewing Department of Health license = \$266.
