MINUTES: Minutes of the May 20th meeting reviewed – *M/S/P – Lisa/Darci*

FINANCIAL REPORT:

Checkbook: Current balance \$8,059.82 (less amount for Chamber Singers not yet paid = \$6,559.82).

- 2012/2013 Programs/Calendars = \$95 First year ever ending positive in this area.
- Fall concessions gross \$8,886.98 net \$3,628.18. Winter concessions gross TD \$27,329.29 net \$11,522.34. Spring concessions gross \$4,758.92 with net \$2,526.14. YTD totals Gross \$40,975.19 and Net \$17,676.66 compared to 2012's numbers of Gross \$40,766.10 and Net \$17,700.87. \$600 startup money given to Kellie on 8-15-12. Should be done at this point but we are still waiting for the 'Healthy Choice' payment from Mankato Clinic/HvVee.
- Cougar wear gross \$15,419.30 with net (-\$4,403.54) starting inventory on a cost basis is \$3,996.40. Apparel for the golf tournament was \$580. Waiting for year-end inventory value.
- Cougar Card deposits to date \$31,284 Exceeded 2012-2013 goal.
- Memberships/Sponsorships/Bricks no change from prior month with amounts respectively at \$700/\$4725/\$75.
- Golf Tournament gross \$3,830 with net \$3,156 w/o any adjustment for Cougar-wear given away.
- Misc. contribution from Matt J Graif of \$130 = % of all tux rentals comes back to Booster Club.
- 2 NSF Checks have been reported for \$10 and \$45.
- We are still waiting for \$900 check from Jersey Mike's for fundraiser. John will follow-up with them.

- <u>\$2,000</u> *Up to* \$2000 approval for work by Sport Pix on canvas photos Collage of black and white photos with pops of cougar yellow in a variety of sizes. These can be resold after display period.
