FINANCIAL REPORT:

- **Checkbook: Current** spendable balance \$29,802.05. This balance does NOT include the following sub-accounts: football stadium project and signage (see below).

ADDITIONALLY:

Scorer's table - 4 proposals:

- ➤ Daktronics (AIM): \$67,800 original quote reduced to \$42,800. The configuration can work with current Daktronic scoreboard. Screen image areas can be digitally split to provide 4 quarters. System allows us to put scoreboard in panel. Additional side panels are backlit and about \$4000 each. Package includes computer, software, training, RFD. Additional training and graphics package = \$1500.
- > Fairplay: \$47,700
- Sideline Interactive: \$38,000 (says they can work with current scoreboard).
- FEPACO = \$38,000 not sure this is compatible or meets our needs.

Recommendation is Daktronics as we know it will be compatible with our system and should work similarly to other Daktronics items we have.
